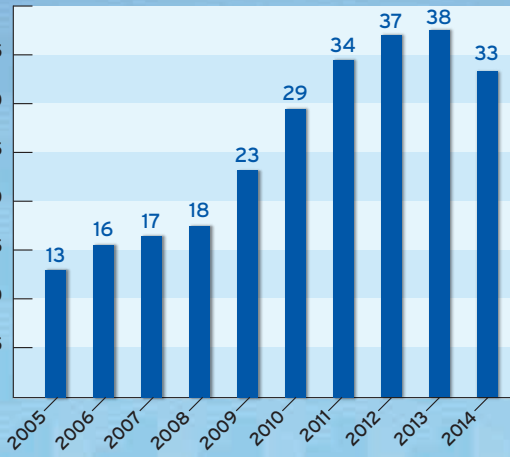
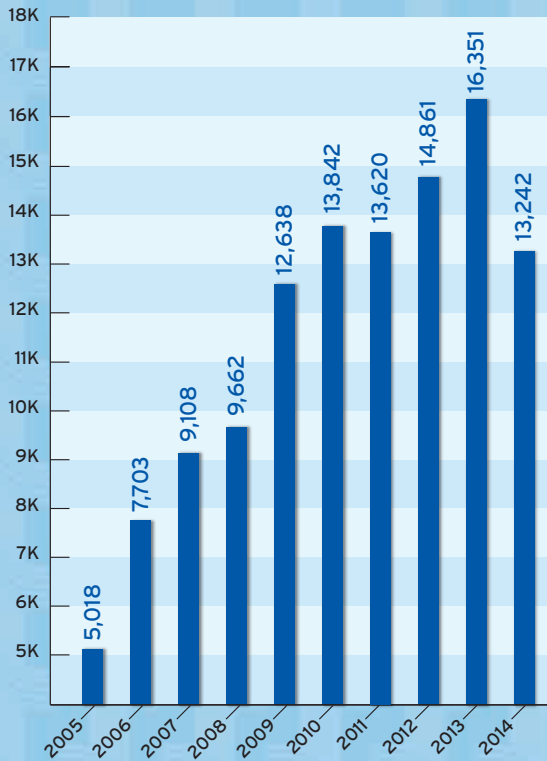


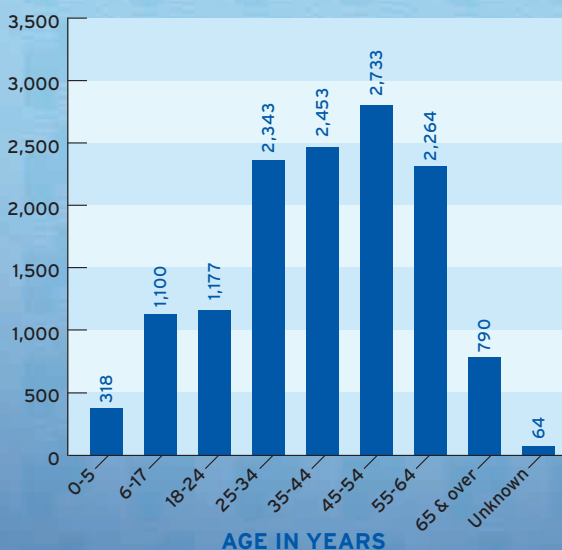

- Free Clinics have expertise and experience in serving Iowa's most vulnerable populations
- Free Clinics will continue to serve those remaining in the gaps
 - Eligible, but not enrolled
 - Eligible, enrolled with unavailable access
 - Eligible, enrolled with unaffordable access
 - In between coverage
 - Undocumented/unauthorized
 - Indigent/homeless
